Indemnity document

TO: Auckland Four Wheel Drive Club Inc. ("Club")

As a Driver ("driver") of the vehicle below, in consideration of you permitting me to take part in a Club Event I WARRANT, AGREE AND DECLARE THAT:

The Parties

- 1. This agreement and Deed ("Agreement") is between
(a) Me, as driver and my passengers (including children) and crew ("my passengers and crew"); and
(b) The Club and Club members (and all other persons having any connection with the promotion and/or organisation and/or conduct and/or participation in a Club event ("event") including: the owner, lessee or occupier of any land, the owner, lessee and driver, crew and passengers of all other vehicles, all other entrants, participants, officials, marshals and any other person involved in the event ("other participants")).

Driver's Responsibilities and Obligations

- 2. I ACKNOWLEDGE AND WARRANT that I have read this Agreement and that:
(a) This Agreement applies to and may be relied upon by the Club, all Club members and other participants; and
(b) My passengers and crew and I are bound by the Club's rules which I will explain to them; I have the authority to bind my passengers and crew and bind them accordingly and I have told/will tell them of their responsibility before starting the event.
(c) All drivers of my vehicle are currently legally entitled to drive in New Zealand.
(d) I am responsible for my vehicle being safe, complying with Club Rules and being operated safely at all times;
(e) My passengers and crew and I are responsible for the welfare, safety and actions of any passengers and crew in my vehicle and other participants affected by our actions and we are liable for any acts or omissions by us; and
(f) My passengers and crew and I will follow all proper directions and instructions of all marshals; and that
(g) I have appropriate insurance for all drivers of the vehicle; and
(h) It is my responsibility to approve recovery, attachment points and where safe to perform the attachment. At any time I can decline or refuse to follow instructions or be towed or to be otherwise involved in any driving recovery or activity. If I accept instructions or a tow or become involved in a recovery or activity I am responsible and liable for anything that occurs.

Waiver

- 3. I WAIVE AND RELEASE, you, the Club, Club members and other participants from all rights and obligations and liability which may be owed to me and my passengers and crew and vehicle, (including liability for any loss or damage to property or personal injury arising out of any act or omission or accident to me or my passengers) so my passengers crew and I agree not to sue and have no claim against the Club, Club members and other participants.

Indemnity

- 4. I INDEMNIFY the Club, Club members and other participants and agree to pay for all and any liability and costs arising out of participation in this event by me and my passengers and crew.
